Code Enforcement

Last month we printed a summary of common code violations. This month we would like to re-print these with additional information on where you can receive assistance if you currently have a code violation, but are unable to make the repairs/changes needed to comply:

Big Blue Trash Cans at the curb on non-trash days. Big Blue should be at the curb only on trash day. If you are physically unable to get your Big Blue to and from the curb you may apply for house-side pickup. Please call 297-2833 for more information.

<u>Cars Parked On Grass</u>. Absolutely no parking on the grass is acceptable.

<u>Cracked or Peeling External Paint:</u> Elderly or disabled residents may request assistance with home repairs (including external painting) by calling the City of Oklahoma City, Neighborhood Services Department, Housing Rehabilitation Office at 297-2846

Big Trash Pick-up Day: Second Wednesday of the month <u>after the first full week</u>. So if the month starts on Tuesday the 1st – the "second Wednesday after the first full week" would be Wednesday the 16th of that month

January Meeting: By-law Amendments Proposed

At the Crestwood Neighborhood Association meeting on Tuesday, January 10th neighborhood association members will be voting to amend the Crestwood Neighborhood Association by-laws. The proposed amendment is to modify Article V, Section 2. The section reads:

Election and Term of Officers. The officers of the Association shall be elected annually from the newly-elected Board of Directors at the annual meeting. Any officer may service only two consecutive terms in the same office. Term of office shall be for one year commencing immediately following the annual meeting in September.

The proposed modification would read:

Election and Term of Officers. The officers of the Association shall be elected annually from the newly-elected Board of Directors at the annual meeting. Term of office shall be for one year commencing immediately following the annual meeting in September.

All CNA members in good standing are eligible to vote. You may become a member in good standing at the meeting, prior to the vote, by paying your CNA dues.
