The Louisville Water Company is scheduled to begin construction on a cathodic protection project in your area. Please find attached a tentative schedule of work for the areas impacted by this project. Weather conditions may affect the actual dates shown on the attached schedule. C.P. Systems International, Inc. will perform the construction.

The project will consist of the installation of cathodic protection on existing water main. Cathodic protection is process in which the water main is protected from corrosion. This work involves excavating a two foot diameter hole along the existing water main approximately every 50 feet. Customers along these routes may experience some disturbance to the yard while installing the cathodic protection. We regret any inconvenience that it may cause you. This work should not cause our customers to experience water outages.

During the construction, a Louisville Water Company Construction Inspector will be supervising the work and its progress. Every effort will be made to restore the affected area to a condition that is equal to or better than its original condition.
