## BURNING OF HOUSEHOLD TRASH IS PROHIBITED IN WOODLIEF

The legal burning hours in Columbia County are BETWEEN 8:00AM (10:00AM FOR RESIDENTIAL AREAS) and 6:00 PM or 1/2 hour before sunset. ALL FIRES MUST BE OUT AND SMOKE FREE BY DARK. Obtaining a burning permit in Georgia is for notification purposes, a permit does not excuse any liability issues your fire or smoke may cause. If someone complains about your smoke we will ask you to extinguish the fire. Legal material permitted through the online permitting system in Columbia County is LEAVES, PINESTRAW and SMALL LIMBS AND BRANCHES (BRUSH). NO STUMPS. Large brush piles are not permitted through this system. For information regarding burning anything other than the above items or other questions, please call 706-556-3962 706-556-3962 Remember, YOU ARE RESPONSIBLE FOR YOUR FIRE AS WELL AS YOUR SMOKE. Use extreme caution and STAY WITH YOUR FIRE with a shovel or rake and garden hose until it is COMPLETELY OUT. (printed from the Georgia Forestry website)
