1. Call to Order: 9:13 a.m.
 - a. Introductions –
 - b. **Colleen Nicol** – City Clerk for the City of Riverside – **Redistricting**
 - 1) Ms. Nicol told us that the Federal Census Data (2010) are official now, and that the City's total population is 303,864.
 - 2) The City Charter requires the City Council to realign the ward district lines every ten years to achieve a population in each ward that is within plus or minus 5% of the optimal population per ward. Optimal population per ward is 43,409.
 - 3) She distributed three maps that illustrate the redistricting recommendations before the City Council.
 - 4) The Wood Streets neighborhood is currently and will remain in Ward 1.
 - 5) Ward 1 will lose part of the Grand neighborhood to Ward 3 to reach the balance requirements.
 - 6) Ward 4 has the largest population and thus each of the recommendations shows new borders around it to accommodate the surrounding wards.
 - 7) The University neighborhood will be redistricted into Ward 1.

 - c. **Lynn Anderson**, field representative for Councilman Mike Gardner.

 - a. An update about Asian Citrus psyllid –Questions and concerns? Call 1-800-491-1899
 - 1) There has been only one infestation found in California, (in Hacienda Heights).
 - 2) To prevent any further incidence of the pest the California Department of Food and Agriculture is taking preventive steps which include local concerns.
 - 3) The CDFA will be spraying our local citrus trees. Many of our neighbors have already received a notice from the CDFA.
 - 4) The CDFA will be using both systemic and topical insecticides in their treatments.
 - 5) The topical spray should be allowed to dry for 24 hours before any fruit is harvested. Wash and rinse the harvested fruit before consuming it.
 - 6) Take anything that you don't want sprayed indoors – like toys or tools.
 - 7) DO NOT TAKE ANY FRUIT OUT OF THE AREA.
