Gutter Guards Installed

At the May meeting, Council approved the installation of gutter guards on 36 units around the community. Those units were chosen based on their proximity to tall trees and their history of accumulating considerable debris, with the goal of minimizing our need for semi-annual gutter cleaning and reattachment. Our semi-annual cleaning and reattachment was costing from just over \$2k to over \$4k depending on the contractor and the amount of reattachment required.

By protecting the gutters of homes with more severe debris issues our aim is to reduce the need for regular gutter cleaning, ultimately reducing our long-term costs.

The units where gutter guards were installed were:

West Court: units 14, 16, 18, and 20

Center Court: units 100, 102, 112, 114, 116, 117, 118, 119, 120, 121, and 123

<u>East Court</u>: units 200, 202, 204, 206, 208, 210, 212, 214, 216, 217, 218, 219, 220, 222, 224, 226, 228, 230, 232, 234, and 236

All installed gutter guards carry a 20-year warranty on both products and workmanship.

12 Tips for Staying Cool This Summer

- Be aware of the heat. Pay attention to it and modify your activities appropriately.
- Pay attention to your hydration status, and be sure to drink plenty of fluids.

- Weather stripping and proper insulation will keep cool air inside your home.
- Cool beverages are good for cooling down the body, while alcoholic drinks can impair the body's ability to regulate its temperature.
