July 24, 2012 General Meeting

- 1) Meeting called to order at 6:40 p.m. by BS.
- 2) Roll call –CF-e, DC-e, TG-ue
- 3) UIRF–
 - a- Hanford Village-Sherry Boyd- HV is submitting a proposal to improve HV Park , by adding sidewalks that connect the park from Gault. Requesting a letter of support from AC.
Q- Is there a cap on funding?
A- The program has \$6 mil. Available to be dispersed citywide. Proposal forms due 7/27 by 4 pm. 109 Front St.
Q- Does letter of support need to be attached to the application?
A- That would be preferred.
MS made a motion to approve letter of support for HV UIRF proposal. LS seconded, passed 6-0-0.
 - b. Driving Park-
SM-There was discussion at the last Economic Development meeting about what is needed in the area, but nothing fits the parameters of the UIRF.
-The circle on Lily Ave that was the center of the DP track needs improvement.
-Need for repaving of Livingston, east of Lockbourne and installation of decorative street lights. MS made a motion to approve letter of support for DP UIRF proposal. LW seconded, passed 6-0-0.
 - c. Old Oaks-
CW- Drafting a proposal for installation of a Gazebo on Wilson Ave. Blvd. to include decorative street lighting and the renaming of the alleys within the Historic District. BS made the motion to approve letter of support for OO UIRF proposal. LW seconded, passed 6-0-0.
 - d. Livingston Park Neighborhood Improvement Association
MS- LP would like to have decorative lighting installed and rename Carpenter.
-A petition signed by all on the street along with approval from the PO is needed for changing a street name. CW made a motion to approve letter of support for LP UIRF proposal. LS seconded, passed 6-0-0.
 - e. LAVA-C
BS-Considering proposal for dedicated bike lanes along Livingston that run under railroad crossing, which would reduce Livingston to one lane at Nelson. Would also like to add decorative street lighting from Rhoads to the west. SM



would be against this idea as it would choke traffic and possibly hurt business west of Nelson. BS, option B would be to rework the traffic signal west of Rhoads improve the crosswalk in line with NDC proposal and create a share-road bike lane at underpass. Would also like to add lighting west from Alum Creek to include area west of the Livingston Ave corridor.

- 4) Brian Willis- The old B& V record store is being converted to a carry-out. They are working without permits, actual address 1475 Livingston is owned by Earl S. Ward.

- Need to contact the church to ensure that they object to a liquor permit. Also contact city attorney, Christian Krolfich, and code enforcement. LW will contact state rep. Stinziano.

- 5) Comments from the Chair-

a. Bylaws state 3 unexcused absences from meetings equal resignation.

Currently, TG has 4, need to work on finding a treasurer as there has been no contact with TG by either email or phone.

LS-TG works late, has a new child, etc. She will try to contact him next time she sees him.

SM- Should give TG the benefit of the doubt and find a way to contact him.

CW- Past history of this, all the way back to the DP AC.

BS- Need to advertise a position opening and solicit resumes.

b. Meeting Space-

BS- has been in contact with NCH about meeting space, would like to move by Sept. meeting and like to propose an amendment to the bylaws that would allow us to move our meeting date to the third Tues. of each month. This would move the Zoning meeting time and location to 6pm at AC meeting space.

CW made a motion to consider the amendment of the bylaws for change of meeting date, and possible move to NCH facility for meetings. LS seconded, passed 6-0-0.

c. Street light removals

The city is proposing the removal of several street lights, one of which being the light at Champion and Mooberry. BS has been in contact with city officials and advocating that the light remain. Will be in search of support when the time comes. d-f. tabled
