## **POOLS WILL BE OPENING SOON!**

All three pools will OPEN Memorial Day weekend, Friday May 27<sup>th</sup>, and will be open 9 a.m. to 10 p.m. daily.

Rules are posted at each pool. As a reminder, all pool guests and children under 16 years of age MUST BE ACCOMPANIED by a Summerfield resident, and the pool gate is to remain shut at all times. This is for the safety of our children and is a state law, and is every resident's responsibility to ensure they are closed. If you find that someone has left the gate open, please shut it immediately.

POOL KEYS will be available after May 1<sup>st</sup> in the Summerfield office for \$25.00.

## PLEASE INSPECT YOUR FENCE! Fences should be in good repair, especially those that face a public area.

## ARCHITECTURAL REVIEW BOARD

If you are going to make any changes to your property such as painting, new garage door, new fence, roof, storage building, etc. you must first obtain approval of the ARB. An application form is available on the website, in the office, or the office can mail residents a form. All applications for painting must be accompanied by a color paint chip. ALSO, any additions made to common areas, such as flowers, shrubs, pots, etc. also require ARB approval. Without approval these are subject to removal.

solicitors: Solicitors have been in the area even though we are a "no soliciting" community. Any solicitors are required to have a license and you may ask them to show it. If they do not provide a license you may call the office or police and give the name of the company or organization represented
