## 2016 Rules for Group Use of Common Area/ Pools

---

1. NO LIFEGUARDS ON DUTY. Homeowners, tenants and their guests swim at their own risk. The Sunrise Homeowners Association, Inc. assumes no responsibility or liability for any accident, injury, or loss of property incurred while using this facility. Pool privileges may be rescinded for rule violations.
2. The following items are **prohibited** within the common area/pools:
  - Alcohol
  - Smoking, including e-cigarettes (on pool property)
  - Illegal substances
  - Animals (except registered service animals)
  - **Football, Rugby, Soccer, or other hard balls**
  - Sunflower seeds
  - Glass containers
  - Metal objects in the pool
  - **Inflatable toys or floatation devices that are not Coast Guard approved**
3. Noodles, non-metal dive toys, **beach balls (under 10 inches), foam or other soft balls designed for use in pools (no hard parts and less than 6 inches across)**, kick boards and US Coast Guard approved children's floatation devices (i.e. water wings, vests, or infant rings with seats) are permitted.
4. No bikes, skateboards, or scooters are to be used within the gated common area.
5. Appropriate swim attire must be worn in the pools at all times.
6. Sacramento County Health ordinances requires "swim diapers" for all children who are not toilet trained. Regular disposable diapers or cloth diapers (unless certified for swim use) are not permitted in either pool.
7. Please shower before using the pool. All swimmers must be free of visible dirt, mud, or debris.
8. No persons shall use the pools if the following condition exists:
  - Any communicable disease
  - Diarrhea
  - Bandages, open sores or wounds
9. Running, pushing, wrestling, fighting, foul language and unwanted splashing of others is not permitted in the common area/pools.
10. Running-dives are not permitted. Diving from the edge is only permissible in the deep end of the pool. No backflips, jack knives, or similar types of diving are allowed.
11. **Do not remove, play with, hang on, or cause damage to the pool safety rope. This rope designates the change from the shallow to the deep end of the pool.**
12. DO NOT play with the Rescue Rings and their ropes as they are for rescuing an injured or struggling swimmer in an emergency.
13. The following items must be kept at least six (6) feet from the poolside, outside the red lines:
  - Electronic devices (volume must be kept low or headphones used)
  - Tables, chairs, and lounges
  - Chairs are not allowed in either pool
  - Shoes/Flip-Flops
  - Food or drinks (water, soda, juice, etc.)
14. Wading/Pool Reminder: Use of the wading pool is **restricted** to children under the age of 6 and an adult must be at the pool's edge supervising at all times.
15. Requesting party is responsible for cleaning the area used.
  - Please place trash & recycling in appropriate bins and clear table surfaces.
  - Please dump ice and water in landscaped areas only.
  - Barbeque grill must be cleaned and all exterior surfaces wiped down.
  - During approved party times, guests must be registered in the guest log.
  - Approved host, or an adult member of the household, is required to stay in the common area/pool as long as their guests are in attendance.
  - Party host is responsible for the conduct of all party guests. He or she is required to communicate any of the above matters that pertain to guest conduct. It is recommended that a copy of the rules be brought to the party.
  - All other SHA pool rules are in effect. (A copy will be provided as well as posted on the common area bulletin board).
