Guest Speaker: **Chief William McManus of the San Antonio Police Department**

Chief McManus attended the HNA meeting to inform those present about what's going on in San Antonio, Tx and the police department. He explained the following:

- \* Consent of Decree: (where two parties agree to settle a dispute without admission of guilt). An example was given regarding an investigation.
- \* How domestic calls are handled.
- \* High speed pursuits have changed to prevent crashes and accidents. Such a pursuit may take place if violence or weapons are involved.
- \* Risk vs. need to apprehend was discussed.
- \* Spoke about the shooting of a person and the tactic that the officer took as safety measures.
- \* Manpower: There are 145 officers down. Eighty are in police academies now. No shortage of officers on the street. By next spring or summer, SAPD should be back to regular vacancy rate.

\*Requirements were changed to become an officer. Gave examples of hiring process.

\*Questions asked about the crime in the neighborhood since January, 2016:

25 vehicle burglaries

23 thieves

19 family disputes

14 vandalisms

13 burglaries

\* Consultant is looking into the 911 calls and communication unit. More call takers are needed.

\*Talk on gang participation – Drug, Vice, and Traffic unit have been involved with keeping down the gang activity.

\* Individuals to talk to HNA about our concerns as it relates to incidents in the our neighborhood.

\* Chief McManus will travel to Washington D.C in recognition for the positive changes that were made in the San Antonio, Tx police department.

### Old Business

- Talked about the sign and how it is to be maintained.

- Concern about the entry way sign. The history of the sign was given by B. Robinette.

- Construction will be starting on the streets....Cypressway between Sugarloaf and Cypress Gardens. Vehicles must be moved or will be towed out of the way.

- Asphalt bumps are being put in.

- HNA reminder signs were stolen after being put up.

- Update on the highway system around the areas.
