

RELEASE, HOLD HARMLESS & INDEMNIFICATION

In exchange for the right to hunt on the property of **Woodlief Community Association, Inc.** (hereafter referred to as Land Possessor), located at **5065 Wells Drive, Evans, Columbia County, Georgia 30809**, the Participant agrees to the following:

Participant waives for his or her executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he or she, individually or in solido, may have or which may arise against Land Possessor, and any of its heirs, employees, directors, officers or agents, including but not limited to any and all injuries, damages or illnesses suffered by Participant and/or Participant 's property, which may, in any way whatsoever, arise out of, be related to or be connected with hunting or in any way connected with his or her presence on the property of Land Possessor. Participant on behalf of himself or herself and his or her executors, administrators, assignees or heirs, hereby expressly release Land Possessor and any of its heirs, employees, directors, officers or agents from any and all such claims.

Participant hereby expressly assumes the risk of entering the land of Land Possessor and of taking part in activities relating to hunting on the land of Land Possessor which include, but are not limited to, archery and the discharge of firearms and the firing of live ammunition and use of and presence on the land of Land Possessor.

Participant agrees to indemnify, hold harmless and defend Land Possessor and any of its heirs, employees, directors, officers or agents from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with archery and the discharge of firearms, use of and presence on land of the Land Possessor. And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, any state, or under any theory of law or equity, Participant will indemnify, hold harmless and defend Land Possessor and any of its heirs, employees, directors, officers or agents, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against Land Possessor and any of its heirs, employees, directors, officers or agents, whether individually, jointly, or in solido with Participant, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

Participant furthermore hereby acknowledges and agrees that he or she has read, understands and will at all times abide by this agreement.

This instrument binds Participant and his or her executors, administrators, assignees or heirs.

WOODLIEF COMMUNITY ASSOCIATION, INC. HUNTING PERMISSION SLIP AND RULES

Hunting on the property of Woodlief Community Association, Inc., located at 5065 Wells Drive, Evans, Columbia County, Georgia 30809, is restricted to Feral Hogs.

Hunting is only allowed in designated areas, which, at minimum, must be at least fifty yards from any resident's property line. Refer to EXHIBIT A for a map of the hunting area.

Hunting is restricted to Archery. However, the participant may carry a hand gun or small caliber firearm to quickly kill feral hogs in a humane manner after they are struck with an arrow.

Trapping is also allowed and firearms may be used to kill feral hogs that have been trapped. All trapped feral hogs must be killed and removed from the property by the participant.

The participant acknowledges that he or she has read and understands, and will abide by, the most current Hunting Regulations as published by Georgia Department of Natural Resources, Wildlife Resources Divisions. Any licenses, permits, hunter safety certificates, etc. required in Georgia for hunting or trapping feral hogs will be maintained by the participant.

This permission is granted by Woodlief Community Association, Inc. to the Participant for one year from the date this form is signed. The permission may be revoked earlier than one year at anytime by Woodlief Community Association, Inc. by notifying the Participant via mail at the address listed below.


