## **November 2017 Meeting Notice/Newsletter**

**Meeting:** The next Wakefield Taxpayers meeting will be held on Thursday, November 16, 2017 at Redeemer Evangelical Lutheran Church (undercroft), 4360 Boyd Avenue (Between Barnes & Boyd Avenue) at 7:30 p.m. **This will be a business meeting followed by a holiday party.** A special election of officers & directors for a 2 year term will take place at this meeting. The swearing-in of new officers & directors will also take place at this meeting.

**Results of October 19, 2017 Election - Failed Election:** At the October 19<sup>th</sup> meeting, an election of officers and directors for a 2 year term was held. 4 people were nominated and accepted the following positions: Virginia Sanders, President; Phyllis Donaldson, 1<sup>st</sup> Vice President; Joan McNish Francis, 2<sup>nd</sup> Vice President; and Carlynn J. Vitale, Treasurer. There was a failure to nominate and accept in the other 7 positions. As a result, no voting was held to elect any officers or directors.

**Notice of a Special Election to be held on November 16, 2017:** We will be holding a special election at our November 16, 2017 meeting to do the entire election over. We will have open floor nominations at the meeting. To be nominated for any position, members must have paid their 2017 dues on or before March 1, 2017 and attended at least 50% of the meetings during the past year. Please consider volunteering for one of the positions. The duties for each position are listed in our Constitution & By-Laws which are available on our website, and a copy will be available on November 16<sup>th</sup>. For your info, the officers handle the day-to-day operations of the non-profit organization; the directors oversee the affairs of the non-profit organization and protect the interest of the members.

**Very Important Note:** New York State Corporation Law and our New York State Certificate of Incorporation require that we have a minimum of 3 Directors.
