2018 BLOCK WATCH SIGN REPLACEMENT PROGRAM

This program is made possible by funding from the City of Phoenix NBWG Program

Program Description: To replace aged and damaged signs currently posted in communities. The goal is to instill pride and to promote the block watch program.

Limitations: This program is limited to replace 2 damaged block watch signs with 2 NEW block watch signs. No sign will be customized for any community. The replacement signs will be the standard block watch signs currently distributed by the Phoenix Block Watch Advisory Board. Damaged signs must be turned into CPCA at the time of receipt of the replacement signs. The damaged signs will become the sole possession of CPCA.

Liability Disclaimer: CPCA will not be held responsible for any personal or property damages that may be incurred during the removal or replacement of any new or damaged signs. CPCA will not be held responsible for the improper installation of any block watch signs or any possible repercussions incurred by any improper installation. CPCA has not implied that the acceptance of any application will be automatic.

Qualifications:

- 1). Must be a registered Block Watch with the City of Phoenix Neighborhood Services Department or the City of Phoenix Police Department.
- 2). A representative of the Block Watch organization must attend 3 CPCA meetings in 2018.
- 3). Applicant is responsible to install the signs according to the block watch sign installation regulations.
- 4). Applicant is responsible to supply the hardware for the sign installation. (Suggestion: Use old hardware if possible.)
- 5). Applicant is responsible to pick up the signs upon C.P.C.A. acceptance and notification of request. (Awarded at next regularly scheduled general meeting – during the meeting.)
- 6). Applicant is responsible to turn in 2 damaged block watch signs and release possession of said signs solely to CPCA at the time of pick-up of the replacement signs.
- 7). Submit the request as outlined below with all information completed and with required attachments.
- 8). Illegible or incomplete forms will not be accepted.
- 9). **Submit a picture of the damaged block watch signs to be replaced with this application.**
