Program Description: To provide individuals, who actively patrol, Vehicle Signs for their PNP patrolling activities. The vehicle signs received via this program will be properly placed on a vehicle while engaged in patrolling as outlined in the Phoenix Neighborhood Patrol (PNP) program. The goal is to instill pride and to promote active involvement in the PNP program.

Limitations: This program is limited to providing one set of vehicle patrolling signs per person which includes the following: 1 roof sign, 1 small rear car sign, 1 large rear sign, and 2 door signs

Qualifications during the 2018 calendar year:

- 1). **Must be an active City of Phoenix PNP member**, trained and certified by the Phoenix Police Department.
- 2). **Attend 3 PNP educational meetings in 2018**, the Cactus Park Precinct briefing or combined CPCA-BW/PNP meetings.
- 3). Applicant is responsible to use the signs when patrolling according to PNP guidelines.
- 4). Applicant is responsible to pick up the signs at a designated meeting upon CP PNP Grant Program Committee's acceptance and notification of request.
- 5). **Applicant must provide CP PNP Grant Program Committee with copies of PNP logs recording 25 patrolling hours (meetings, event participation, etc. are not considered eligible patrolling hours) during the 2018 calendar year.** Please attach copies of the 2018 patrolling logs to this application upon completion and submission.
- 6). Submit the request as outlined below with all information completed.
- 7). Illegible or incomplete forms will not be accepted.
- 8). Return this completed application along with copies of the 2018 patrolling logs verifying 25 hours of patrolling in 2018 by mailing the documents to: Cactus Park PNP, P.O.
