Subject: Reopening of Pools

Following [guidelines](#) issued this week by the County of Riverside and the City of Palm Springs, the Esprit Palm Springs HOA board will be reopening the pools on Saturday, May 9th at 8:00 am.

The opening will follow the guidelines set forth by the County of Riverside (<https://www.rivcoph.org/coronavirus>). The notice below will be posted on the pool gates. We ask that unit owners immediately share this information with rental tenants as everyone is expected to follow these guidelines, no exception.

While we want you to enjoy the pools, the Board takes the safety of everyone seriously and we want to make it clear that violations will be addressed swiftly with penalties and an immediate shutting down of the pools. Please respect the rules and keep everyone safe.

Please note that use of the pool is limited at this time to current Esprit owners and renters. No guests of either is allowed at this time. We hope future notices will allow for further reductions in restrictions.

Please note that the spa continues to remain closed until further update and the pool is unheated during this time of the year.

Thank you for your patience as we try to keep everyone safe.

RULES FOR USE OF THE POOL AREA

Eff. May 9, 2020

- All residents must avoid the pool area if they are experiencing symptoms of illness including a fever of 100°F or above, sore throat, runny nose, chills, not feeling well, sneezing, coughing, abdominal pain, or diarrhea.
- Use of pools and pool area is strictly limited to current Esprit owners and renters. No guests of either is allowed at this time.
- Six feet of separation is required at all times, except for families from the same household.
- Pool limited to exercise and cool off only.
- No flotation devices allowed, no exceptions.
- Swimmers must use lanes for swimming and keep 6 feet distance from other swimmers at all times.
- Use of pool limited to 30 minutes - All owners will be responsible for self-managing this.
- No large groups or pool parties allowed.
- Loungers, chairs, and tables have been properly distanced. **NO FURNITURE CAN BE MOVED. ALL OF IT MUST REMAIN AS PLACED.**
- You may use your own furniture, but the furniture may not remain in the pool area once you exit.
- Face coverings must be worn while in pool area.
- All users must bring hand sanitizer (not alcohol based, which does not kill germs) or disinfectant of that strength. Users must sanitize **BEFORE AND AFTER USE** all of the surfaces they touch - including gates, latches, tables, chairs, loungers, pool handrails, and umbrellas.
- When you leave, you must take everything you brought into the pool area. **DO NOT LEAVE ANY TRASH.**
- Please observe all other posted pool safety regulations.
- Spa remains closed – please do not enter spa.
- Violations of any of these rules will be addressed swiftly with penalties and an immediate closure of the pools.
- If any resident fails to follow any of the above restrictions, they will lose their right to use the pool area and could be fined.

Note: At this time of year the pool is never heated.

All users are advised that use of the pools is at their own risk as we are unable to police the pool area.
