## •Rolling Fork Pool Rules For 2020

(Swimming is a privilege and rules will be enforced)

1. No person is allowed in pool area when pool is not open or a lifeguard is not on duty.
2. All persons using pool and facilities do so at their own risk.
3. All residents must check in with the gatekeeper before entering pool area. Resident's guests are limited to eight (8) per residence address. Residents must remain in the pool area at all times with guests.
4. Children under 10 years of age must be accompanied by a responsible adult at all times. The lifeguard is not responsible for children under 10. Responsible adult must be within arm's length of children who are not able to touch the bottom of the pool or children wearing flotation devices.
5. Baby pool – children 5 and under only. Parents, not lifeguards, are responsible for children in the baby pool. Only swimmers diapers allowed in either pool
6. Do not talk to the lifeguards unnecessarily. The lifeguards are for everyone's protection and should not be distracted.
7. Do not climb on lifeguard stand; sit near sign-in table, or lifeguard stand.
8. Only one person at a time is allowed on the diving board. Double springing is not allowed. Clear the diving area immediately after you dive. No diving is allowed in the shallow end of the pool.
9. No flotation devices in diving area-only in shallow end of big pool at lifeguard's discretion.
10. No paint, crafts, etc., are allowed that may damage or cause change to the area facility or its contents.
11. No pets, skate devices, bicycles, glass containers, or balls allowed in the pool area.
12. No holding or hanging on to center of pool rope.
13. No alcoholic beverages allowed in pool area. No intoxicated individuals may enter or remain on premises.
14. No cooking in pool area. Place all litter in trash cans.
15. No running, pushing, horse-play, or games that interfere with residents in pool area. No breath holding games.
16. No firearms or deadly weapons are allowed on the premises except by certified peace officers or licensed and certified security personnel in the course of their duty. No fireworks are permitted at any time.
17. Profanity, loud music and smoking are not allowed in pool area.
18. No private swimming or diving lessons may be given at the pool.
19. A 10-minute break is scheduled each hour. Adult swim is at lifeguard's discretion. Children must be 5 feet away from all sides of the pool during break.

●The lifeguard has the authority to enforce these rules and to discipline or expel anyone breaking the rules or creating a nuisance or unsafe condition. If the above rules are not followed :

**1st infraction – swimmer out of pool for 30 minutes**

**2nd infraction – swimmer leaves pool for remainder of day (if end of day –swimmer is out next day)**

**3rd infraction – swimmer is out for 3 days;**

**4th infraction – swimmer is out for 2 weeks**

## •Rolling Fork Private Pool Party Policy

(Available only for Rolling Fork Residents or community related organizations)

1. All requests for private pool parties must be made **two weeks in advance** and coordinated through the Swimming Pool Committee and Aquatic Management of Houston.
2. There is a \$25.00 rental fee payable to Rolling Fork Owners Committee and a \$150.00 deposit for cleaning. Return of deposit is dependent on condition of pool and surrounding area. When reserving the pool you must complete the **Pool Party Request Form**. Aquatic Management of Houston will then advise the Swimming Pool Committee of this information. The renter is then responsible for direct payment to Aquatic Management of Houston for the lifeguards. The number of lifeguards will be dependent on the number of party attendees (not swimmers) who will be in the party, at the cost of \$20.00 an hour plus a \$20 non-refundable administration fee. 4. Renters are responsible for assuring all trash is bagged and brought to trash collection area.
5. Private pool parties may be scheduled only during non-community pool hours (except if there is swim team practice).
