



Hello, neighbor. You are receiving this newsletter as a resident of the Stonewater subdivision and as a member of the Stonewater Homeowners Association. It's been awhile since your board of trustees has offered a newsletter about the neighborhood, its activities and its issues. We promise to be more diligent in keeping you informed.

While residents might know information on these topics, it's a good time to offer a refresher and to bring attention to them to our many new residents.

**But first, some information about a current problem.**

All-terrain vehicles, or ATVs, are **prohibited** on all Stonewater streets and common areas, and on undeveloped properties. There have been numerous complaints about particular ATVs and their operators. These complaints are being examined by homeowners association trustees and the management company. There will be further information about this problem and a solution as it becomes available. The situation is of great concern and is being addressed.



## A bit of history about Stonewater

Since development began in 2006, Stonewater has seen numerous changes and growth. What 14-year-old hasn't? The biggest change affecting the subdivision as it exists came in 2011, when Serendipity Development Corporation took ownership. You might know it as Lindbergh Properties Construction.

Serendipity filed a Declaration of Covenants, Conditions, Reservations and Restrictions for Stonewater Subdivision. That document was received and recorded by Jefferson County in November 2011. You can find a copy of the document in PDF for at:

Since that time, Stonewater grew from about 20 homes from previous builders and developers to more than 100. Section 2 opened this year with rapid home construction. Section 1 has lots remaining but is near completion. Section 3 is platted but remains undeveloped.

Covenants address architectural guidelines, property owner duties and responsibilities, subdivision management and your rights regarding the HOA.

### **So what is the Stonewater Homeowners Association?**

You are the HOA.

Under the covenants document Stonewater Homeowners Association was incorporated and a board of managers was created. The board consists of at least three members, all volunteers. At present they are Joe Humphrey, Sheila Price and Ray Slover. James Pope leads the beautification committee; Jennifer Holshouser leads the welcome committee.

The covenants document makes it clear that **all homeowners in Stonewaters are members of the association**. All property owners have voting rights, one vote per lot.

The current status of the board will remain effective until all lots are sold. At that time, an election of managers will be held.

**Managers are responsible** for disbursement of funds to pay for:

- **Street lights and signs**
- **Snow removal**
- **Insurance to protect properties owners in case of legal action**
- **Street maintenance**
- **Maintenance of common areas**

To better perform its duties, Stonewater managers (or trustees) **this year hired Ernst Management Services LLC**. Ernst is not an HOA company; it is an administrator that works with homeowners associations. Renee Ernst takes an active role in auditing and accounting of Stonewater funds, and in enforcing covenant regulations.

## About Stonewater

Your subdivision grows daily, with homes being built in Sections 1 and 2. Streets open are Stonewater, Rolling Stone, Waters Edge, Living Water, Waterfall Way, Watering Stone and Living Stone. Those streets contain two roundabouts and three cul-de-sacs. There is a lake behind homes along Waters Edge and two ponds.

Herculaneum annexed Stonewater and is responsible for police protection, as well as providing water, sewer and trash services. Stonewater streets will be accepted for city maintenance at a later date.

**Reminder:** Trash is picked up every Friday, except for weeks with national holidays. Recycling is highly encouraged, and pickup is every other Monday, except for weeks with national holidays. For more information, contact [Waste Connections](#) at 636-321-2100.

So why do you have a Pevely mailing address? Postal service areas predated Herculaneum's annexation. Stonewater is in Herculaneum but is served by the Pevely post office.

Stonewater is in the [Dunklin R-5 School District](#), which covers Herculaneum, Pevely and surrounding unincorporated areas. Students are also served by [Jefferson College](#) in Hillsboro.

In addition to [Herculaneum police](#), emergency services are provided by the [Dunklin Fire Protection District](#) -- that's its station on Hwy. Z -- and the [Joachim Platin Ambulance District](#). Calls for emergency services are made to 911 through [Jefferson County 911 Dispatch](#).

The community lake provides fishing opportunities, access to Joachim Creek and a hiking path via gateways off Waters Edge. If you are a nature lover, you may see deer and geese near the lake. If you are lucky, you also might see migrating ducks as well as eagles and hawks.
