You can keep the cost down by putting the trash in plastic bags or any other method that will make for a quick and easy pickup at your home. Rossman will still come around Monday morning for their regular garbage pickup. Wait until after the regular pickup is complete at your home before you take the additional items to the curb. Again, your comments on this service are welcome.

CURBSIDE COLLECTION: In lieu of dumpsters, the Homeowner's Association has been contracting with Rossman Sanitary to pick up trash at the curb. This has been more convenient and more economical. The next pickup will be on Monday, March 30 at $8:30\,$ AM. Simply set out your garbage cans and your extra trash at the same time. The first truck will empty only your garbage cans and ignore the rest. A second pickup will follow and take all the remaining stuff. Please put your trash in plastic bags or other containers that can be lifted into the truck. We are paying Rossman by the hour as well as by the compacted cubic yard, so it is to our advantage to make it easy to load.



CHARLIE BLAKE LEAVES BOARD: In September 1975, the original developer of Bryant Woods turned over the operation of our Homewoners Association to the residents of Bryant Woods. Our Board of Directors is set up to have three Board positions come up for election each year. This coupled with the fact that we have had a lot of turnover with Board Members moving or being transferred, has allowed a lot of residents the opportunity to serve as a Director. Charlie Blake volunteered to serve on that original Board back in 1975 and has been one of the most active Board Members ever since. A chemical engineer for Hercules Inc., Charlie has been the one responsible for the operation of our swimming pools. His knowledge of pumps and chemicals kept the old pool going and assured the startup and continued operation of the new complex. He has recruited and supervised the youg person employed by the Association for pool maintenance each year. Although he probably visited the pool almost every day during the summer to check on it's operation, Charlie is not a swimmer and rarely used the pool. During the Association's lawsuit two years ago, Charlie was one of the individuals who spent two weeks of their summer vacation in a courtroom in Oregon City. As noted, we have turnover each year on the Board of Directors, but few have contributed so much for so long. The Bryant Woods Homeowners Association thanks you, Charlie Blake, for all you have done. We are sorry to see you move and will miss you.

ANNUAL MEETING: Friday, September 25th, we will hold our annual meeting at the Farwest Federal Savings and Loan located in Lake Grove. Beginning at 7:30 PM, the meeting will offer members an opportunity to voice their views on the operation of the Association and elect five Board positions (the three open by expiration of a three year term as well as two open by movement of Board members). The nominating committee is comprised of Tony Lake, Dave Schulz, and Chris Gould. They are seeking recommendations and nominations will be accepted from the floor. Plan to be there!!

POOL REMAINS OPEN: As is the custom, the swimming pool will remain open until the end of September. Although the pool doesn't open for general swimming until 10:00 AM, early morning lap swimming is permitted.

SPECIAL CURBSIDE PICKUP: The remaining curbside trash pickups are Monday September 15th and Monday November 25th.



Your new Board of Directors met last week and elected officers and selected Committee Chairman. A complete roster appears below. Board meetings are held monthly, normally on the first Monday of the month at the home of one of the Directors. The meetings are open to all members and any interested homeowner is encouraged to attend.

With summer behind us already, it's time to do some fall planting. We have budgeted to continue planting trees in the park area each year until we complete the master landscaping plan. With the spring work party such a big success, we are planning a fall work party this Saturday beginning at 10:00 AM. We will plant trees in the park area as well as clean up the other common areas. The Association will provide sandwiches, beer, and soft drinks. Bring your shovel and come join us in sprucing up the neighborhood. You don't have to spend the whole day, even an hour helps. A job list will be posted at the pool.

Now that the pool and park area is looking good, some homeowners have suggested that we develop other common areas. The settlement from the lawsuit provided funds only for the paths, the pool and the park. We stretched those dollars to include drainage systems in three problem areas. The rest of the common areas were to be left natural. Most of the areas should be left natural, however, in some areas some limited landscaping might improve on nature. During the next months, the Board of Directors will be looking at the common areas piece by piece to see what may be appropriate. Appreciate we do not have a big pot of money to spend on further development, but if you have suggestions on specific common areas please pass them on to a Board Member.
